20221 LEGISLATIVE UPDATE FROM PROVIDENCE STRATEGIES LOBBYING FIRM, BY MICHAEL MASON

General Election Day is November 8, 2022

The cooler weather has arrived here in Maryland as November starts a busy month with the General Election right around the corner. Candidates are making their final push to try and persuade voters, as some Marylanders have already made their way to the polls. Early voting centers opened their doors on October 27th and will remain open until November 3rd, 7:00am – 8:00pm daily. Additionally, Marylanders have until November 1, 2022, to request a mail-in ballot.

Those choosing to vote by mail need to return their completed ballots by November 8th either by mail or placed in a designated ballot drop box. Results will be posted on the State Board of Election website on November 8th, after the last polling location has closed (*link below*).

Information from the State Soil Conservation Committee

Thanks to the Board Supervisors and District Managers that joined our training "Building Better Boards" at the summer MASCD meeting. We encourage everyone to review the information shared following the meeting, and let SSCC know the ways we can support recruiting and retaining Board Supervisors.

The SSCC welcomes Dr. Jim George to the Committee as the new designee from the Maryland Department of Environment.

Highlights of recent SSCC meetings are summarized below.

Urban Agriculture Initiatives

In July, Neith Little, UM Extension agent in Baltimore City, shared updates on Urban Agriculture initiatives being led through the university including a new webpage, YouTube videos and webinars, and increasing farm tours for interested stakeholders. The growing demand for technical assistance and support of urban agriculture in Maryland has also led to the creation of 2 new state positions with UM Extension - urban production methods and crop management, and urban farm and agribusiness management. Funding for the positions will start in July 2023. Additionally, 1 new educator focused on local agriculture and food systems will be hired. The position will be based in Howard County.

Neith also shared the preliminary results from "The Current State of Urban Agriculture in the Northeast US", a survey of 406 respondents. Among other questions, respondents indicated that the top barriers to success were land access, land security, balancing a living wage for farmers with selling affordable food, and regulations, zoning, and building codes.

Next, Bill Tharpe, MDA, shared information on the Urban and Small Farm programs being developed at MDA. The goal of the program is to capture the smaller operations currently ineligible for traditional cost-share through MDA. Assistance would be available through three initiatives, all still in progress: 1) a microgrant program of \$5-10K per award to install eligible conservation practices. Applications would be reviewed and awarded competitively; 2) an annual grant program for producers with at least 5 years of production experience. Applicants could request their needed budget up to a maximum amount; and 3) an Urban Agriculture Water and Power Infrastructure Grant Program consistent with House Bill 855 that passed in 2022. Funding will become available in FY24.

Next, Rob McAfee, NRCS, provided an update on NRCS state and national efforts to expand programs for urban ag operations. In Maryland, a new DC - Colleen Keiffer - will be focused on urban ag in PG, Washington, DC, and Baltimore City. Two additional Soil Con staff to support her efforts will also be hired. In addition to increased technical assistance, Maryland NRCS is looking at practice scenarios based on key practices and scale (i.e.

square feet vs. acres) for urban farms. Nationally, an Office of Urban Ag and Innovative Production was established through the 2018 Farm Bill to better focus on the needs of urban operations. The Office is housed within NRCS and includes an Advisory Committee to develop policies and recommendations for supporting urban ag. A representative from Maryland is a member of the Advisory Committee. Additionally, USDA has established 17 county office committees for urban ag across the U.S.

Finally, Steve McHenry, MARBIDCO, spoke of his agency's efforts, along with Maryland Farm Bureau and the Chesapeake Bay Foundation, during the 2022 legislative session to increase the state's focus and assistance for urban agriculture. This partnership generated important outcomes. MARBIDCO will focus on access to land and innovative finance and debt financing for small acreage operators. The popular Next Gen program will also continue with expanded capacity for smaller acreage. MARBIDCO is also creating a small grants program to support equipment and capital needs for urban agriculture, along with financial support to Future Harvest's Beginner Farmer program graduates.

Following the presentations, attendees were invited to participate in a roundtable discussion of technical assistance needs of the urban and small farm operations in their areas. Highlighted needs included: land and water access, equipment, deer deterrent, stormwater capture from high tunnels, and better understanding of local zoning regulations. As an initial step to address the latter, the Harry Hughes Center and UM Ag Law Education Initiative have created a zoning matrix and leasing template as education resources for operators.

Forest Harvest E&S Process

Dan Rider, DNR, provided an update on the Forest Harvest E&S process. Dan reminded attendees that MDE has updated its guidance on E&S measures for forest harvest in 2015 to more appropriately reflect industry standards. Following the guidance update, DNR and MDE worked collaboratively to distribute outreach material and train appropriate field staff. This ultimately led to a formal MOU between the agencies in 2018 with the goal of a "predictable, consistent and efficient regulatory process" especially for enforcement related cases. The MOU outlined the protocols for addressing complaints, interpreting compliance, and sharing of information between the agencies. As a result, Maryland Forest Service has developed additional capacity to be involved in every timber harvest in the state, and to document its status. The collaboration has been well received by both agencies, and industry is complimentary of consistent guidance that acknowledges the good performers and focuses energy, rightfully, on non-compliant loggers.

Information from the State Soil Conservation Committee

MDE Guidance on Small Ponds

Jennifer Smith, MDE, provided an update on MDE's Small Pond review policy in September. MDE has been working with SCDs and MASCD for several months to finalize guidance on the engineering and technical expertise that will be required of SCDs that continue to perform some small pond reviews. The NRCS delegated engineering JAA for this activity expired January 1, 2022. In the interim, some SCDs have been sending applications to MDE for review, but the hope is to provide clear, technical guidance to support SCDs in retaining the service. As such, MDE finalized its policy in August 2022 with the following,

- Affirms MDEs support of SCDs to approve small ponds;
- Lays out expectations for qualifications of technical reviewers and approvers that is meant to equal the qualifications of NRCS staff who previously performed these reviews;
- Sets up a framework for SCDs to bring in 3rd parties to support review;
- Discusses the new cold water review process; and
- Restates many existing COMAR requirements (such as notifications to MDE of small pond approvals and as-built acceptance)

Jennifer reviewed the specifics of the policy and process, taking questions from the SCDs and SSCC throughout the discussion. Next, MDE plans to hold trainings with SCD and relevant staff, as well as notify the regulated community of the changes.

MARYLAND'S BEST EXPO SCHEDULED FOR JANUARY 10

The Maryland Department of Agriculture (MDA) will host the Maryland's Best Expo on Tuesday, January 10 from 10 a.m. to 2 p.m. at the Navy-Marine Corps Memorial Stadium in Annapolis. Returning for its 19th year, after being canceled in 2021 and 2022 due to the COVID-19 pandemic, the Maryland's Best Expo provides an opportunity for Maryland farmers, seafood producers, and processors to connect with buyers from grocery retailers, restaurants, schools, food distributors, and other venues. "This premiere event plays an important role in connecting our Maryland farmers and producers to buyers from around the state," said MDA Secretary Joe Bartenfelder. "Over the past two decades, MDA's Marketing Program, Maryland's Best, has promoted our state's agricultural and seafood products, and expanded markets for our farmers and producers. I am incredibly proud of their work and grateful for their efforts."

The 2020 Maryland's Best Expo attracted more than 300 attendees. Participants included farmers, producers, watermen, aquaculturists, processors, grocery store retailers, restaurants, schools, institutions, distributors, economic development officials, University of Maryland Extension (UME) agents, and regional agricultural marketing officials. This year's event will be held in the "N Room" at the Navy-Marine Corps Memorial Stadium, 550 Taylor Avenue in Annapolis. Registration is required. The deadline to be included in the expo directory is December 9, 2022, and the last day to sign up is January 6, 2023. There is a \$25 fee for a table display space. NACD POSTER AND PHOTO CONTEST

The 2022 Poster Contest "Healthy Soil, Healthy Life" is open for submissions until December 1, 2022. Winners will be announced during NACD's Annual Meeting in February.



Submissions for the 2023 Poster Contest "One Water" will begin February 20, 2023 through December 1, 2023. Winners will be announced during NACD's Annual Meeting in February 2024.

The annual NACD and NACD Auxiliary Poster Contest provides students from kindergarten through 12th grade the chance to have their art displayed as part of a national conservation outreach initiative. Each year, the winning posters reflect NACD's annual Stewardship theme and highlight the work of conservation districts and their state conservation associations, auxiliaries and agencies to protect and enhance natural resources. The contest starts at the district level; winners advance to the state level, and then to the national level, where they receive recognition at NACD's annual meeting.

The poster contest is open to public, private and home-schooled students. The top three posters in each category of the national contest will receive monetary prizes. First-place winners will receive \$200; second place winners will receive \$150 and third place winners will receive \$100.
