## AWARDS

The Association has assisted with, and or presents on its own, a number of awards including the Goodyear Awards, the Environmental Conservation Education Awards, the District Attendance Award, and a number of service awards. (Goodyear Awards were discontinued in 2001.)

Rule #5, page 2.1, provides for a Farm Credit Awards Committee.

Rule #6, page 2.1, provides for an Awards Committee to judge the:

- a. Conservation Education Teacher Awards. Information is on page 3.05.
- b. Conservation Education District Awards. Information is on page 3.07.
- c. MASCD Service Awards. Information is on page 3.09.
- d. District Attendance Award. Information is on page 3.16.

All awards are based on the calendar year except the Teacher Awards, which are based on the previous school year.

Important dates for the awards are:

- a. **Farm Credit Award** (Goodyear Awards were discontinued in 2001) Send to MASCD by May 1 or as specified by the Committee.
- b. **Teacher Awards** Send to MASCD by April 1, or as specified by the Committee.

### **Goodyear/NACD Conservation Awards Program**

(Ended 2001 – Replaced by MAFC)

The Goodyear/NACD Conservation Awards Program was started in 1947 in the Great Lakes and Corn Belt States. Other states were added in the following years. Maryland districts became eligible in 1953. This was a national program carried out through the state associations of conservation districts. Districts were judged on a calendar or fiscal year as determined by each association and, until 2000, the winners received a free trip to Arizona the following year compliments of the Goodyear Co. In Maryland, the program was judged by a committee composed of the chairperson of the most recent winning district, a representative of the State Soil Conservation Committee and a representative of the NRCS. See Operating Rule #5. Districts were judged primarily by comparing their annual activities with their Annual Work Plans.

Initially, the program in Maryland was operated on a fiscal year basis. From 1964 to 1976, the calendar year was used. The fiscal year was used again starting with the 1976-77 contest year. In 1988 the Association voted to return to the calendar year. Starting with the 1984-85 contest year, two first place districts were chosen and a supervisor from each was awarded a trip to Arizona. Prior to this, first and second place districts were chosen and only the first place district supervisor along with that district's outstanding cooperator was given a trip. In 1992 the program was returned to the procedure of selecting only one first place district known as a Grand Award District. A district could only receive the grand award once in five years. An Honor Award could be given to a district that was not eligible for a Grand Award.

A number of changes became effective for 2000:

The Grand Award District trip to Arizona was eliminated. There would be special recognition of all the Grand Award Districts during the NACD annual meeting. Each Grand Award District would complete on a regional basis and a Regional Grand Award District would be selected for each of the seven NACD regions. Each state would select a Conservationist Of The Year from among the District Outstanding Cooperators. The Conservationists Of The Year would complete on a regional basis and a Regional Conservationists Of The Year would be selected. The seven Regional Grand Award Districts and the seven Regional Conservationists of the year would receive special recognition in Washington, D.C. during the NACD spring legislative conference. In 2000, St. Mary's SCD was awarded the Northeast regional grand award.

The Goodyear Awards were discontinued in 2001. This program was replaced in 2002 with a new state award called the Outstanding District Award. In 2005, MidAtlantic Farm Credit became the sponsor of the award and the name was changed to MidAtlantic Farm Credit Outstanding District Award. (See page 3.03)

After 2000, Goodyear ceased to be the NACD sponsor of the Outstanding District Award and the Soil Conservation Leaders Association developed a separate award for Maryland.

## Farm Credit Outstanding District Award

In January 2002, the MASCD gave the Soil Conservation Leaders Association (SCLA) the responsibility for developing and implementing an outstanding district award to replace the Goodyear award which was discontinued in 2001. The name selected for this new award was the Maryland Outstanding District For \_\_\_\_\_ (year). Criteria for selecting the district includes all activities of the districts; meeting attendance, educational activities, planning, reporting, conservation practices installed, etc.

In 2004, the SCLA contacted the Farm Credit to seek sponsorship for the Outstanding District Award and they agreed to sponsor the award starting in 2005. The award was renamed the Farm Credit Outstanding District Award to recognize their support and J. Robert Frazee, president of Farm Credit, attended the 2005 awards ceremony and presented the awards.

The award is presented each year during the annual meeting for district activities during the previous calendar year. Any one district is not eligible to receive first place more than once in three years. Honorable mention is given to any district that scores high enough to be first place but is not eligible because of the once in three years restriction. The judging committee may give honorable mention to a district that scores very close to the first place district.

The SCLA was designated as the judging committee for this award. In 2003, the SCLA elected to include a representative of SSCC and NRCS as part of the judging team and in 2005, the Farm Credit was invited to be a part of the judging team.

As a result of the Farm Credit funding, starting with the 2004 awards presented in 2005, the following cash awards are now provided to districts:

### MASCD AWARDS COMMITTEE (Rule 6)

A five member Awards Committee was established in 1989 to judge the Environmental Conservation Education Awards, MASCD Service Awards, and District Attendance Award. The committee will include one supervisor from each of the five areas as named in SCD Law. Terms will be for five years and will be staggered so there is one new member each year. Committee members will be elected by the area they represent in the Area Meeting during the Annual Meeting. Each area will report the names of the committee members they elect during the full membership meeting (General Session) where this information will be recorded in the full membership meeting minutes. Any vacancy may be appointed by the President until the next area meeting. The President will appoint the chair and may appoint advisors. The committee shall arrange with the Annual Meeting Program Committee for presentation of the awards. The committee shall notify the appropriate districts about any award to be presented to a person, such as a teacher or an employee, who would not ordinarily be attending the meeting. Such notice shall give time for the district to arrange for the person to attend. Committee members are/were as follows:

## **ENVIRONMENTAL CONSERVATION EDUCATION AWARDS**

In 1974, the National Association Of Conservation Districts and the Allis Chalmers Company started the Environmental Conservation Education Awards Program. Two awards, a Teacher Of The Year and a District Of The Year were given. These awards later became the NACD - Deutz-Allis Awards and in 1990, ICI Americas, Inc. became the sponsor of the Program. ICI Americas, Inc. became Zeneca Ag Products in 1994. MASCD cooperated with NACD in selecting State winners for entry in the NACD, Northeast Area competition. Certificate awards were given to the most outstanding area teacher and district. Beginning in 2004, due to a loss of sponsor, winning applications are no longer sent to NACD.

MASCD adopted the NACD program as a specific MASCD awards program in 1978 with provisions to annually make awards at the state level. The objectives of the program are to create an awareness and appreciation of the value of environmental conservation education and to stimulate efforts by soil conservation district officials and teachers to advance the wise use, protection, and enhancement of the State's soil, water, and related natural resources. State winners are the MASCD entries in the NACD Environmental Conservation Education Awards Program. Guidelines for judging the program, as provided on the following pages, are in general the same as for the NACD program and are subject to change to meet requirements for the NACD program. Beginning in 1993 two teacher awards were given in the NACD program, K-6 and 7-12. In 2004, NACD lost the sponsors of the Environmental Conservation Education awards but MASCD agreed to continue with the award. The winning teacher and district are no longer sent to NACD to compete at the regional and national level. Plaques are provided at the MASCD awards ceremony and cash awards are provided to the winning teachers.

### **CONSERVATION EDUCATION TEACHER AWARD**

Starting in 1974 a teacher in grades K-12 who had been personally responsible for implementing an outstanding environmental conservation education program in his or her school system received the MASCD Conservation Education Teacher of the Year Award. The districts were encouraged to make an award at the district level. The winning teacher's entry was forwarded to NACD for the national competition.

All teachers in public, parochial, and private schools in Maryland are eligible to compete for the award. The candidate must teach on a regular basis in grades K-12. Each candidate must have been actively teaching on a full-time basis during the school year. The teacher's nomination must be endorsed by the soil conservation district in which he or she is teaching. District officials are not eligible to compete. Teacher nominations must be submitted to the district by February 1st. District teacher nominations must be submitted to the MASCD Office for distribution to the Awards Committee by March 1st or as specified in correspondence sent out by the Awards Committee. Teacher awards are based on information available through the previous school year.

In 1986, the MASCD Teacher Awards were broadened to give certificates and cash awards for a number of teacher categories. The Association voted to solicit contributions from the districts, \$50.00 per district, to give cash awards. A cash award of \$300 for first place and \$100 for second place was provided for each of three categories, (Elementary, Middle and High School). One of the first place winners was selected for the NACD competition.

Beginning in 1993 two teachers awards were given in the NACD Program, K-6 and 7-12. In 2004 the NACD changed their policy

### **CONSERVATION EDUCATION DISTRICT AWARD**

Maryland Soil Conservation Districts are eligible to compete for the Conservation Education District of the Year Award. Districts are judged on the nature and extent of conservation education in the schools as well as the degree of leadership in educational activities in the district. Nominations must be submitted to the MASCD Office for distribution to the Awards Committee by March 1st or as specified in correspondence sent out by the Awards Committee. The winner selected for Maryland is presented with a plaque at the annual awards ceremony.

**MASCD SERVICE AWARDS**  
**(For contribution to district programs)**

In July, 1975, the Association adopted an awards program to recognize the service of outstanding supervisors, employees, cooperators and others that make significant contributions to district programs. The program and a list of winners are attached. Also, attached is a list of recipients of the State Soil Conservation Committee Outstanding Employee Service Awards which were given 1980-86.

During the years, many supervisors, cooperators and district employees have made significant contributions to the furtherance of soil and water conservation in Maryland as well as in the nation as a whole. In order to recognize this fine work, the Maryland Association of Soil Conservation Districts adopted the following Awards Program. An Awards Committee was selected as provided in the Operating Rules to select a winner in each of ten categories listed below. The recipients will be duly recognized at the Annual MASCD Meeting and presented with a suitable mounted or framed certificate. Entries do not necessarily have to be made by the districts and the Committee will have the option of selecting a winner whether nominated or not or the option of not selecting a winner for a particular category if the Committee determines it is not warranted. All nominations should be accompanied with a brief but clear and well defined description of why the individual or group is deserving of the Award. There will be no more than one winner per category. Nominations must be submitted to the MASCD Office for distribution to the Awards Committee by April 1st or as specified in correspondence sent out by the Awards Committee.

**AWARD:**                   **Outstanding Leadership**

**ELIGIBILITY:**           All Past and Current District Supervisors

**CRITERIA:**              This award is for a supervisor who has demonstrated considerable leadership in the development of conservation programs and in the execution of the duties and responsibilities of the position of District Supervisor.

**AWARD:**                   **Special Achievement**

**ELIGIBILITY:**           All District Supervisors

**CRITERIA:**              This award is for a supervisor who has made significant contributions in such program activities as RC&D, River Basins or other areas deemed appropriate by the Awards Committee.

**AWARD:**                   **Outstanding Contributions By A New Supervisor**

**ELIGIBILITY:**           Supervisors who have served two years or less

**CRITERIA:**              This award is for a new supervisor who has made unique and/or outstanding contributions deserving of special recognition.

**AWARD:**                   **Outstanding Contribution**

**ELIGIBILITY:**           Persons or Organizations Outside of MASCD and SSCC.

**CRITERIA:**              This award is for an individual or organization that has made a significant contribution to District Programs. Possible recipients of this award would be private citizens, legislators, representatives of industry, Federal, County or State officials or their organizations.

- AWARD:** **Outstanding Cooperator**
- ELIGIBILITY:** The outstanding District Cooperator in each District.
- CRITERIA:** The committee will select from among individual district's outstanding cooperators one whom they deem deserving of Statewide recognition. Each district will annually submit their nominee to the Committee in the prescribed manner and will submit such supplemental information deemed appropriate by the Awards Committee. Sufficient information should be submitted to allow the Committee to make a good choice.
- AWARD:** **Outstanding Associate**
- ELIGIBILITY:** All Associate Supervisors.
- CRITERIA:** This award is presented to an Associate Supervisor who has made a significant contribution to any phase of District activities.
- AWARD:** **Employee Special Achievement (New in 1992)**
- ELIGIBILITY:** All employees located in the field office; e.g. District Managers, Technicians and Clerks.
- CRITERIA:** This award is presented to an employee who has made a significant contribution to any phase of district activities.
- AWARD:** **Outstanding Employee**
- ELIGIBILITY:** All employees located in the field office; e.g. District Managers, Technicians and Clerks.
- CRITERIA:** This award is presented to an employee who over time has consistently demonstrated considerable leadership and excellence in the execution of multiple duties and responsibilities.
- AWARD:** **Outstanding Contribution by Youth or Youth Organization**
- ELIGIBILITY:** Youth or youth organization for individuals under 18 years of age.
- CRITERIA:** This award is for an individual under 18 years of age or a youth organization for individuals under 18 years of age that has made a significant contribution to District programs.
- AWARD:** **Outstanding Newsletter (New in 2004)**
- ELIGIBILITY:** All Soil Conservation Districts
- CRITERIA:** This award will be presented to the district that produces the best newsletter/s in the previous year. The committee will judge the newsletter/s on the timeliness, frequency, presentation, how informative, audience, etc. To be eligible for the award, districts will submit copies of the district newsletter/s from the previous calendar year along with a list of the recipients by category (i.e. cooperators (#), all landowners (#), engineering companies (#), legislators (#), etc.).

In 1982, a coalition of corporations, associations and individuals; concerned about the continuing serious soil erosion, water depletion and contamination which threaten America's Agricultural economy; formed the National Endowment For Soil and Water Conservation. The Endowment is a non-profit, privately funded, non-political organization dedicated to conserving our nations agricultural resource base. One of the programs created by the Endowment was the National Soil and Water Conservation Awards Program, sometimes referred to as the Outstanding Conservation Farmer Award. In 1990, the Endowment created the Good Earth Council which carries out the program under the name, Good Earth Family Award.

Through the program, a farmer who implements outstanding soil and water resource management and abatement techniques, is selected in each state. Ten national finalists are selected from among the state winners. Three national winners are selected from the ten finalists. MASCD coordinates the program in Maryland to select a Maryland State winner.

## ENVIROTHON

The Envirothon Program, carried out through SCDs, is a competitive environmental educational program for high school students. It supplements local schools' environmental curricula with hands-on field activities and teaching by natural resource professionals. Students are trained and tested in five natural resource fields: forestry, soils, wildlife, aquatics, and a current environmental issue. They compete progressively at the county, state and national level. Begun in Pennsylvania in 1979, the Envirothon has spread to 44 states and 8 Canadian Provinces. 22 of Maryland's 23 counties and Baltimore City are involved with the program.

The Envirothon program is a unique partnership between high school science teachers and natural resource professionals. Together, they offer a broader environmental education program than either could separately. Student teams and teachers work closely with biologists, foresters, and soil scientists training for local, state, and national contests. All training is conducted outdoors in natural settings. Teacher surveys and discussions with state and local education officials emphasize the need for such real-life, hands-on outdoor educational experiences. The program develops student's critical thinking, problem solving, communication, team-building, and decision-making skills using real life, local environmental issues. Envirothon training is both science-based and practical; it emphasizes field inventories, identification, and problem solving. Without the Envirothon, this high quality field training would be unavailable to students.

The success of the program in Pennsylvania was discussed at the January 1989 MASCD meeting and a resolution was passed stating, "MASCD recommends the development, promotion and support of a contest system to ensure that a team from Maryland will compete yearly in the National Envirothon." The Association also passed a resolution that "MASCD supports creation of an Envirothon endowment fund, administered by MASCD, to provide financial support to the Envirothon program on a statewide basis."

The Allegany SCD initiated the Envirothon in Maryland in 1990. The first state program in Maryland was in 1991. In 1992 MASCD voted to use the interest from its endowment fund for the Envirothon. A long time funding committee for state and national Envirothons was established in 1995. This was later merged into the MASCD Envirothon Committee, (pg 3.31). Maryland hosted the National Envirothon in 1992 at St. Mary's College. Thirteen states competed in the competition that had a budget of \$30,000.

In 1996 MASCD passed a resolution establishing a more active role with the Envirothon. It agreed to serve as the treasurer for the state Envirothons and provide funding for the state and national Envirothons to the greatest extent possible.

Since 1990, Maryland's Envirothon Program has been a model for many new states entering the Envirothon arena. Maryland tries to incorporate some of the states graduating requirements into the yearlong program. This involves completing community-based environmental projects which enable the students involved to achieve some of the graduation requirements of 75 hours of community service through planning, design, fund raising, media, implementation, and reflection. The Maryland program also incorporates poster & video sessions, and most recently oral problem presentation as part of the state competition.

The Envirothon has been successful due to the efforts of many individuals who have worked on the Envirothon Committee, organized local events, provided natural resource training, etc. Kathleen Diehl (NRCS Public Affairs Specialist 1990-95) and Craig Hartsock (Allegany SCD Manager) initiated the Maryland Envirothon Program in 1990. Kathleen worked to build a strong program and was instrumental in early fund raising efforts. She also served on the national committee. Don White (Southern Maryland RC & D Coordinator 1994-96) also helped strengthen the fund raising efforts for the Envirothon program. Craig Zinter (Talbot SCD Manager) filled Kathleen Diehl's position on the National Committee in 1993 and served as Chairman from 2001-2003.

In 1996, MASCD was awarded a grant from EPA to hire a coordinator to develop a Junior Envirothon Program with guides for teachers and high school mentors including examples of activities and training materials. Penny Jenkins, a high school teacher from The Western School of Technology and Environmental Science in Baltimore County, was contracted with to prepare the program. She developed curriculum and activities for a middle school Envirothon. The first MASCD State Junior Envirothon was held at the Patuxent Wildlife Center on November 11, 1996.

At the March 26, 2002 meeting, the Board approved the “Operational Procedures of the Maryland Envirothon” (Page 3.26) and at the MASCD Annual meeting in July 2002 the MASCD Envirothon Committee was eliminated as its functions were superseded by the new Maryland Envirothon Steering Committee.

In 2000, the Maryland Envirothon Steering Committee submitted a bid to host the 2003 Canon Envirothon (the national Envirothon became known as the Canon Envirothon in 1999 due to the fact that Canon provides major sponsorship for the event). Maryland won the bid and began the planning process that took 3 years to complete. The committee that organized this event, headed by co-chairs Karen Miller (Kent SCD Manager), and Barry Burch, was made up of 25 people committed to putting on an extraordinary program. Over 50 local businesses and organizations contributed to the event, which was a huge success, attracting 41 states and 6 Canadian provinces. Over 200 volunteers contributed their time and/or expertise. The 2003 Canon Envirothon was held July 26-August 1, 2003 at Mt. St. Mary’s College in Emmitsburg. At the end of the competition, Maryland’s home team from Montgomery County placed 5<sup>th</sup> out of 47 teams. Canon distributed prizes and scholarship money worth over \$30,000 to the winning teams.

In 2000, The Envirothon Steering Committee established The Outstanding Service Award. Recipients are shown on page 3.23.

In 2003, MASCD received a grant from MDA (administered through Washington County SCD) to hire a part-time contractual Envirothon Coordinator. Clare Seibert was hired to assist with the 2003 State and 2003 National Canon Envirothon. She resigned in October 2006. In 2007, Cheryle Franceschi was hired as the new Envirothon Coordinator. Cheryl resigned June 2009 and Holly Caldwell took on the role November 2009. Holly moved out of state and had to relinquish the position December 2012. Craig Hartsock was hired to take over the responsibilities beginning January 2013.

**OPERATIONAL PROCEDURES OF  
THE MARYLAND ENVIROTHON STEERING COMMITTEE**

**ARTICLE I - NAME, PURPOSE**

Section 1: The name of the organization shall be The Maryland Envirothon Steering Committee (MESC), and serves under the auspices of the Maryland Association of Soil Conservation Districts (MASCD).

Section 2: The MESC is organized exclusively for scientific and educational purposes of promoting, organizing and funding the Maryland Envirothon. Specifically the Maryland Envirothon is a natural resource education program sponsored by local soil conservation districts for high school age students. This education program stresses the interdependence of various natural resources within the environment via county and state competition events. The Envirothon emphasizes hands-on, team-oriented problem solving.

**ARTICLE II - MEMBERSHIP**

Section 1: Voting membership shall consist of:

- 2 representatives of Maryland's Soil Conservation Districts from each of the 5 geographic areas of the state, Western Maryland, Central Maryland, Southern Maryland, Upper Eastern Shore and Lower Eastern Shore;
- The Treasurer of MASCD;
- 2 representatives from the Maryland Department of Agriculture, Office of Resource Conservation;
- 1 representative from each of the following divisions from the Maryland Department of Natural Resources - Forest Service and DNR - Wildlife and Heritage Division and DNR - Fisheries Service
- 1 representative of the Maryland Agricultural Education Foundation
- 2 representatives from the Maryland Department of Environment;
- 2 representatives from the USDA Natural Resources Conservation Service; and
- 3 At-Large positions, which may be appointed annually by MASCD

Section 2: Duties of Members

Members of the MESC will discharge their duties in good faith, with ordinary care, and in a manner they believe to be in the best interest of the Maryland Envirothon & the Committee.

**ARTICLE III - OFFICERS / TERM OF OFFICE**

There will be 4 officers of MESC consisting of a Chair, Vice-Chair, Secretary, and Treasurer.

The Chair and Vice-Chair will be selected from the members on the MESC who are also associated with one of the 24 Soil Conservation District members of the Maryland Association of Soil Conservation Districts. The Treasurer will be the MASCD Treasurer or their representative.

The Chair and Vice-Chair will be elected in accordance with the procedures in Article VI, Section 3. In order to serve as Chair or Vice-Chair, the individual must be a representative of one of the 24 Soil Conservation District members of the Maryland Association of Soil Conservation Districts and have been a member of the MESC for at least one (1) year.

The Chair, Vice-Chair and Secretary will serve two-year terms. The Treasurer will serve in accordance with their MASCD term of office. The Chair and Vice-Chair will have staggered terms and can be re-appointed.

## **ARTICLE IV - DUTIES OF OFFICERS**

### **Chapter 2 Section 1: Responsibilities of the Chair**

The Chair shall convene regularly scheduled Committee meetings, shall preside or arrange for other members of the executive committee to preside at each meeting in the following order: Vice-Chair, Secretary and Treasurer.

The Chair will coordinate meeting dates and locations as well as distribution of notices with the Secretary.

The Chair will represent the MESC on the North American Envirothon Committee.

### **Chapter 3 Section 2: Responsibilities of the Vice-Chair**

The Vice-Chair will chair sub-committees on special subjects as designated by MESC. The Vice-Chair (or the Executive Committee designee) will serve as a member on the North American Envirothon Committee.

### **Chapter 4 Section 3: Responsibilities of the Secretary**

The Secretary shall be responsible for keeping records of committee actions, including overseeing the taking of minutes at all committee meetings, and for receiving written resignations from Committee members. In addition, the Secretary shall be responsible for sending out meeting announcements as coordinated with the Chair or his representative, distributing copies of minutes and the agenda to each committee member, and assuring that committee records are maintained.

### **Chapter 5 Section 4: Responsibilities of the Treasurer**

The Treasurer shall give a report at each committee meeting. The Treasurer shall chair the Finance Committee, assist in the preparation of the budget, help develop fund raising plans, and make financial information available to: committee members; to the MASCD; the State Soil Conservation Committee and if requested; to the public. The Treasurer will present the annual report of funds to MESC at the first meeting of each calendar year.

## **ARTICLE V - REGULAR MEETINGS**

### Section 1: Regular Meetings.

The Executive Committee shall set the dates, times and place of the regular quarterly meetings.

### Section 2: Special Meetings.

The Chair or the Executive Committee may call special meetings. (See Article VII, section 2 for Executive Committee makeup).

### Section 3: Notice.

Notice of each meeting shall be given to each member, by mail, FAX or email, not less than fourteen (14) calendar days before the meeting.

## **ARTICLE VI - COMMITTEE ROLES, MEETINGS**

### Section 1: Committee Role, Size, and Compensation.

MESC is responsible for overall policy and direction of the MSEC, and delegate's responsibility for day-to-day operations to the Chair or Co-Chairs. MESC shall have up to 30 and not fewer than 10 members. MESC members receive no compensation.

### Section 2: Meetings.

MESC shall meet at least four (4) times per calendar year, at an agreed upon time and place.

Section 3: Committee Elections.

Election of officers will occur as the first item of business at the first meeting after the North American Envirothon of that year, but before October 31. Officers will be elected by a majority vote of the current members present.

Section 4: Terms.

All Committee members shall serve 4-year terms, but are eligible for re-appointment. Terms run on a calendar year basis and appointments or re-appointments are to be provided in writing to MASCD by the appropriate agency, unit of government, organization or soil conservation district.

Section 5: Quorum.

A quorum must be attended by at least 10 MESC members, one of who must be an officer, before business can be transacted or motions made or passed.

Section 6: Notice.

An official Committee meeting requires that each MESC member have written notice fourteen (14) days in advance via FAX, email, or postal service.

Section 7: Vacancies.

When a vacancy on MESC exists, the appointing agency/organization will be contacted to appoint a replacement, which will complete the remainder of the term.

Section 8: Resignation, Termination and Absences.

Resignation from MESC must be in writing and received by the Secretary. A Committee member shall be dropped from MESC for excess absences if they have missed 75% of scheduled Committee meetings in a year. A Committee member may be removed for cause by a three-fourths vote of the remaining Committee members.

Section 9: Special Meetings.

Special meetings of MESC shall be called upon the request of the Chair or one-third of MESC. The Secretary shall send out notices of special meetings to each Committee member postmarked two weeks in advance, or via FAX or e-mail two (2) weeks prior to the special meeting.

Section 10: Proxies

A member may vote by proxy executed in writing by the member and submitted to a member of the Executive Committee.

**ARTICLE VII - SUB-COMMITTEES**

Section 1: Sub-Committees:

MESC may create sub-committees as needed, such as fund-raising, housing, etc. MESC Chair appoints all committee chairs.

Section 2: Executive Committee.

The Executive Committee shall be comprised of the current Officers of the MESC, in addition to a representative from: the Maryland Department of Agriculture - Office of Resource Conservation; USDA, Natural Resource Conservation Service; the Maryland Department of Natural Resources; the Maryland Department of Environment and 1 representative of the Soil Conservation Districts. The Chair in consultation with other officers and agencies concerned may appoint additional members of the Executive Committee.

Except for the power to amend the Operational Procedures of the Maryland Envirothon Steering Committee, the Executive Committee shall have all of the powers and authority of MESC in the intervals between meetings of MESC, subject to the direction and control of MESC.

Section 3: Finance Committee.

The Treasurer is chair of the Finance Committee, which includes three other Committee members. The Finance Committee is responsible for developing and reviewing fiscal procedures, a fund raising plan, and annual budget with staff and other MESC members.

Section 4: Nominating Committee.

The Chair will appoint a nominating committee during the spring quarterly meeting. It is the responsibility of this committee to present to the MESC a proposed slate of officers that will be voted on during the fall quarterly meeting.

**ARTICLE VIII - STAFF/EMPLOYEES**

Section 1: Staff/Employees are to be employed by MASCD. Rules and regulations of MASCD will be followed in matters of personnel.

Section 2: The executive committee may propose to the MESC any action to hire, fire, promote or discipline staff/employees of MESC.

Section 3: Any action proposed by the executive committee will be detailed, including position descriptions, reasons for termination or promotions or other personnel measures. The MESC will review and adopt these actions at a regular or special meeting. The MESC Executive Committee will then make recommendations for final actions to the Maryland Association of Soil Conservation Districts Board of Directors.

Section 4: the executive committee on an annual and semi-annual basis will evaluate any staff/employee. This will be based on: the job description; work assignments and; quality of work.

Section 4: Staff/employee salaries will be submitted in writing to the MASCD Board of Directors prior to hiring of any staff member/employee. The written salary schedule will be provided with an offer of employment.

**ARTICLE IX - AMENDMENTS**

Section 1: These Operational Procedures may be amended when necessary by MASCD.

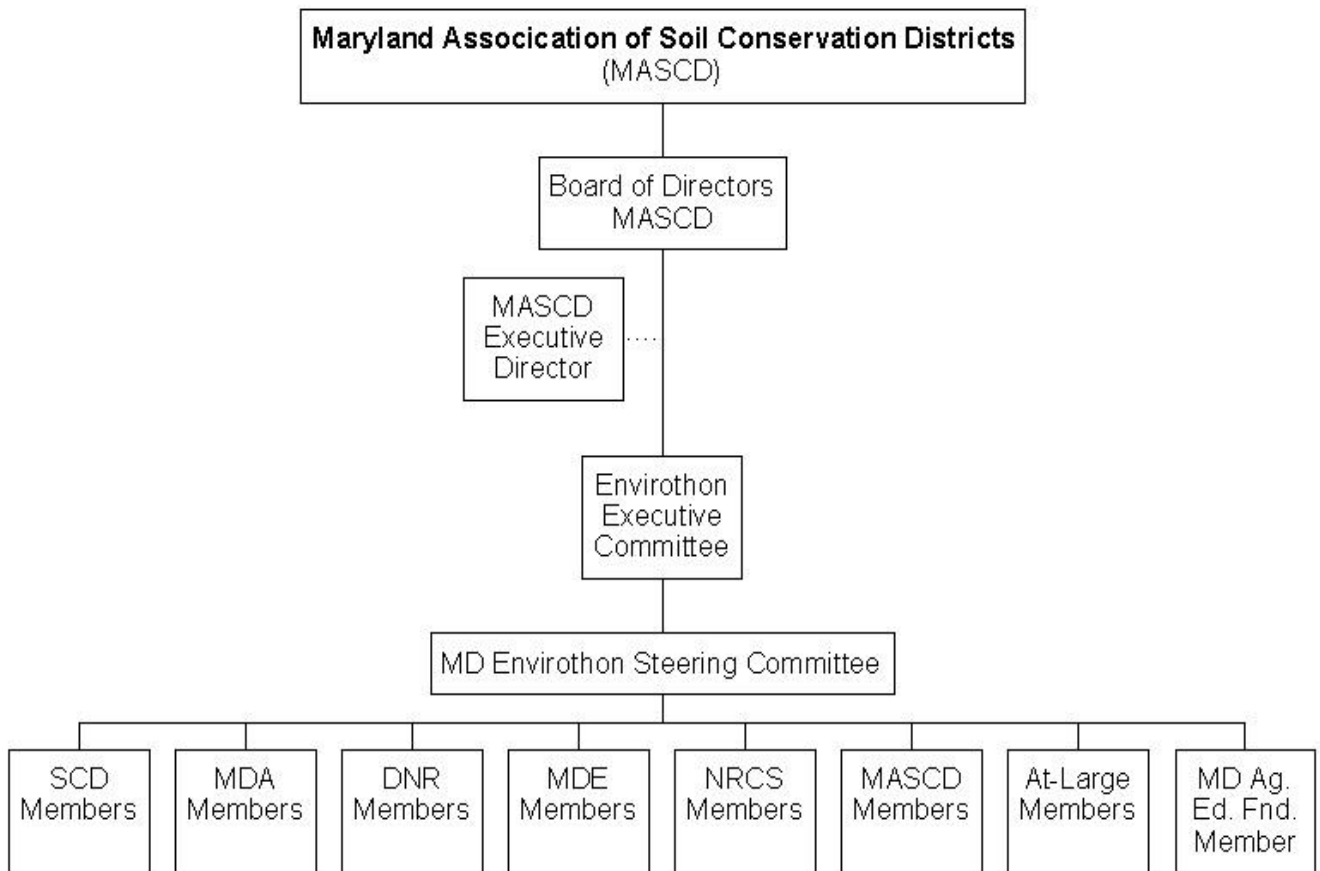
